### 3. New Easthampton AgCommission – now 138 total statewide.

The Easthampton City Council, thanks to great organizing work by Councilor Andrea Burns and a wide-ranging group of Easthampton farmers, unanimously passed an Ordinance creating an Easthampton AgCommission. That brings the statewide total to 138 AgComs and 111 Right to Farm Bylaws.

### 4. Easthampton City Council Resolution

Easthampton City Council recently passed the following resolution:

"Regarding the use of local agricultural produce in school lunches"

September 15<sup>th</sup>, 2010, Submitted by Councilor Burns

**WHEREAS:** The City of Easthampton recognizes the importance of fruits and vegetables as part of a nutritional diet for the health of our residents, especially our children, and

**WHEREAS:** We understand the importance of healthy food in reducing the occurrence of childhood obesity and associated health concerns, and

**WHEREAS:** We support our farms in Easthampton and neighboring communities for the preservation of our cultural heritage and for the economic benefit and,

**WHEREAS:** We support legislation, in both the Federal and State legislatures that promote the "Farm to School" project, be it

**RESOLVED:** That we the City Council of Easthampton, MA, hereby recognize the commitment of our city's food service contractor (Chartwells) to use fruit and vegetables from small and medium sized farms in school lunches year-round and that we make it a priority to favor companies in the future that follow a policy of purchasing local agricultural products.

## 5. Gill warrant article to exempt farms from excise tax on animals, machinery, and equipment

Gill Town Meeting recently passed the following article:

"Shall the Town of Gill cease assessing the excise imposed under General Laws Chapter 59, Section 8A on certain animals, machinery and equipment owned by individuals and non-corporate entities principally engaged in agriculture?"

# 6. Support information for AgComs interested in proposing to exempt farms from the excise tax on animals, machinery, and equipment

Cheryl Lekstrom, MDAR Contractor, has kindly provided the following information and suggestions:

#### **Waiver of Animal Excise Tax**

Towns that have waived animal excise and farm equipment excise tax: Berlin (May 11, 2009, vote was 150-40), Stow (passed May 12, 2009), Rowley, Oakham (Passed May 18, 2009), Cambridge, Hatfield

(Note: we would like to hear from other AgComs whose towns have proposed or passed farm excise tax exemptions.)

Section 2 of the Dairy Farm Stabilization Act, Chapter 310 of the Acts of 2008, provides: "Section 8A of chapter 59 of the General Laws, as so appearing, is hereby amended by adding the following paragraph: 'The local appropriating authority, as defined in section 21C, may, by a two-thirds vote, seek voter approval to not impose the excise established by this section."

When requesting a waiver of farm animal and equipment excise tax, AgComs might want to consider these talking points:

- 1. Many of the excise tax bills are for less than the cost of collection.
- 2. The creation of the bills makes for complicated valuation decisions.
- 3. Go back to the fairness principle applied to the Cost of Community Services from The

nationwide American Farmland Trust study): The REAL property tax contribution of privately owned working lands subsidizes residential land uses that do not cover their own costs. Is it fair that farm properties which generate more public revenues than they receive back in public services continue to be taxed?

- 4. You can waive it by law. If you (as an AgCom) didn't at least request it, then you wouldn't be looking out for your community of farmers.
- 5. Many towns have never charged an animal or equipment excise tax and many towns that used to discontinued doing so three or four years ago due to #1 and #2 above.

Berlin's speaking points, generously shared by the Berlin AgCom, are as follows:

The DOR issued a ruling in February 2009 that a vote to eliminate the Farm Tax had to be done by referendum at a Town Election and not at a Town Meeting. So, at the Ag Com's request, the Select Board unanimously voted to put our referendum on the May 11, 2009, ballot.

The AgCom then went to the local newspaper and had an article written on the subject just before election day. The main points in the article were:

The Commonwealth's Dairy Preservation Act 310 of 2008 allows towns to cease assessing farm excise tax on farm animals, machinery and equipment for ALL FARMERS.

- At present, farms in Berlin pay an average of \$232.18 (FY05-FY09) in Farm Excise Tax.
- On some farms, the equipment and machinery being taxed is 40+ years old!
- Studies have shown that farms contribute more to town treasuries than they receive in services (It costs the towns less to have farms than it does to have more homes or malls).
- A YES VOTE will eliminate the administrative tasks for both the Assessors' and the Tax Collector's offices by not collecting the Farm Excise Tax.
- A YES VOTE will have minimal fiscal impact on taxpayers and the town while helping to sustain the farming activities that currently exist in Berlin and preserve our quality of life.

### 7. Winter Amherst Farmers Market

The following is a message from Michael Docter, a member of the Hadley AgCom and formerly manager of the Western Mass Food Bank Farm.

Bug Hill Farm's Black Currant Cordials.....And if it gets cold, Balky Farm has hats, gloves and mittens knitted from their own sheep wool!

Because local food is always a cause for celebration, we are making it a festive event with free music from Darlingside. There will be prepared local delicacies served by The Turkish Kitchen, Tom Hidas' Curried Veggies (formerly of Amber Waves Restaurant) and the Black Sheep Deli. Live music too. Don't miss it!!!
